Men between the ages of 18 through 25 are required to register with the Selective Service System. This requirement applies to all male U. S. citizens and male non-citizens, with only a few exceptions. Please review the requirements on the Selective Service website at [sss.gov](http://sss.gov) for detailed information on this requirement.

Male students who have not registered with the Selective Service will not be considered eligible for financial aid without a valid reason for not registering.

I have not registered with the Selective Service because:

- I am female.
- I have not reached my 18th birthday.
- I was born before 1960.
- I am/was a citizen of the Republic of Palau, the Republic of the Marshall Islands or the Federated States of Micronesia. A citizen or national of the Republic of the Marshall Islands or the Federated States of Micronesia who lives in the United States for more than one year for any reason except as a student or employee of the government of his homeland must register.
- I am/was a noncitizen who first entered the U.S. after I turned 26.
- I am/was a noncitizen who entered the U.S. as lawful nonimmigrants on a valid visa and remained in the U.S. on the terms of that visa until after they turned 26.
- I am a transgender male who was assigned the sex of female at birth.
- I have not registered for a reason not listed above.

\_\_\_\_ A Status Information letter from Selective Service System. This letter is obtained by calling 1-847-688-6888 or visiting the Selective Service website at [sss.gov](http://sss.gov) (click on Registration Information, then click on Men Over the Age of Eligibility to Register).

\_\_\_\_ A letter describing your situation during the period when you should have registered (18-25 years of age). The letter should include where you were living, whether you were incarcerated or institutionalized, your citizenship status during the time period and any other pertinent information. You must give reason why you did not receive correspondence from the Selective Service reminding you to register. Also please give reasons why you were not aware of the widely publicized requirement to register when you were of the age of 18 thru 25. If you did attempt to register, you should also state this.

\_\_\_\_ Any supporting documentation, I-94 entry documents, refugee documents, etc.  
This request form, along with **SUPPORTING DOCUMENTATION**, must be submitted to the Office of Financial Aid.  
A request without documentation will not be considered.
